





2021 saw the completion of renovations, although we have not been able to use them to their fullest. We were unable to have full capacity in many areas, and most spaces were under utilized; the "CP Canteen" in the outdoor area only opened once. However, it is great to see the "White Mouse Café" being well utilised throughout the day for coffee and snacks. COVID once again saw a reduction in Commemorative Services. We held an unofficial Dawn Service at the Frankston Cenotaph with 30 -40 turning up to honour the fallen. It was pleasing to see at the Dawn Service one of the local community clubs that we support. The Langwarrin Football Club came together around the "Flame of Remembrance" to honour our service men and women. Driveway services were also held by many locals throughout the

We are pleased to have our Wellbeing Coordinator, Stellar and the VFWC Manager, Ange Northeast working closely together in the Veterans Room to provide both Wellbeing and Compensation Advocacy to the many service members both within our club and the surrounding districts. This service has also given us access to professional psychiatrists and social workers employed by ANZAC House to assist us with some of our more complex cases.

While it was difficult to get large groups together due to restrictions we were able to be part of DVA Veterans Health Week by attempting the 10,000 steps program with several teams from within the club competing against each other.

The culmination of this was announcing the winners at a Christmas luncheon held in Simpson Room 1 for members of many organisations within the club.

### GENERAL MANAGER'S REPORT

"The Leadership team has worked tirelessly throughout the pandemic dealing with the lockdowns, restriction outcomes, and constant Health Department changes. With a workforce exceeding 100, the biggest challenge they found was dealing with their individual teams' mental and financial struggles."

First and foremost, I would like to thank everyone from our Committee, Management group, and wonderful team, who have all contributed to enabling our organisation to come through these testing times in a healthy and stable position. 2021 proved again to be a very challenging and demanding year, requiring us to be creative, innovative, and responsive to

our staff and our membership.



The additional COVID lockdowns took its toll in a lot of areas within our system, resulting in a lot of stopping and starting that caused regular interruptions to our operations. Together with the lockdowns we had restrictions that changed each week, isolating for COVID cases and close contacts, plus the enormous pressure on our Management team as they endeavoured to keep their teams together. The fact that we were able to provide continued financial support to most of our staff through programs such as Jobkeeper and Jobstart, and our own resources., helped us retain most of our staff. A bonus of the lockdowns was that the management team had time to relook at our systems and structure in all areas of our operations to see if they would be workable in the new norms facing us post COVID.

Despite all the lockdown issues we were able to complete our development by the end of February 2021, and, I'm pleased to say, under budget. This ensured that our finances remained in a strong position, helping us rebound out of the pandemic with positive energy and focus. The fantastic support and expertise that both the Architect BSPN and Builder HRM provided throughout the project, particularly with the

completion, was very much appreciated by Management and Committee. A special thank you must go to all the sub-contractors who contributed so diligently to the project regularly going out of their way to ensure the building wasn't delayed.

The Hospitality Industry state-wide has been severely affected with the conducting of their operations, bearing the brunt of the Government restrictions. Unfortunately, this has caused a lot of our workforce to rethink their employment in the industry, resulting in a lot moving to other employment. Together with supplier issues and the constant negative media around the pandemic, it has obviously caused concern with a large part of our membership and community.

You can rest assured that the focus of our organisation is the health and wellbeing of our membership and workforce, and this will be ongoing as we address the new norm in 2022. Community Support Fund

Your Committee continues to be very conscious of our Corporate Social Responsibility and, despite pandemic closures and restrictions, our focus has been to still meet our community and kindred organisations club funding obligations. Many Community events and competitions were unable to be conducted making it very difficult for the organisations, and their wonderful volunteers. It is hoped that things continue to settle, and it enables the groups to get back to some normality and again become financially viable.





#### **Industry Challenges**

### Gaming Changeover – August 2022

Back in 2010 we faced a major decision when the State Government of the day chose to restructure our Gaming Industry. That resulted in the RSL network joining the Tabcorp Gaming Services (TGS) in August 2012 in a 10-year deal finishing this year 2022. The Government this time around has expanded the timeline to 2042 with two 10-year options.

Frankston RSL has decided to purchase our machines and utilise the services of the new RSL Gaming Service group to assist with the operational aspects. This partnership will enable us to have more control on what happens on the Gaming floor and help stabilise the future.

#### Development

Despite all that COVID threw at us the fantastic development has been completed and as I write this report the 12-month review was conducted between ourselves, builder, and architect to finalise any defects and issues, and pleasingly, beside a couple of small problems, everything was fine and signed off by all parties. Management is very excited as the COVID restrictions are eased enabling us to open our whole venue and provide new experiences for all members. In the coming months you will notice a lot of promotions and events returning plus some exciting new experiences happening around the new areas of our club.

### FINANCIAL SUMMARY

### TREASURER'S REPORT

Well, what an interesting trading year 2021 was. Nearly four months of lockdown and other trading restrictions mandated by the Victoria Government. Notwithstanding these restrictions the Sub-Branch had a reasonably good trading year, albeit over a reduced period. The positive trading coupled with a strong closing balance at the end of 2020 resulted in a closing cash balance for 2021 of \$3,341.747.

General Account. This is the commercial account for the Sub-Branch responsible for Bar, Food, Entertainment and Gaming activities. Despite the significant impediments on our trading caused by the COVID-19 restrictions the Sub-Branch had a reasonable positive trading year, with improved sales in Bar Trading and Gaming. This resulted in an overall profit for the year of \$186,889. Building Patriotic Fund. The Patriotic Fund is the true owner of Frankston RSL's land, building and all other fixed assets. The Sub-Branch as user of the premises and fixed assets pay a rent to the Patriotic Fund, which for 2021 was \$1,200,000. The rent is paid from the Sub-Branch General Account and used to service the bank loan taken out for the recent redevelopment. During 2021 loan repayments of \$291,200.00 were made with a further \$200,000.00 being committed in December 2021, which was processed in the first week of January. At the end of 2021 the outstanding loan balance was \$5,923,800.00.

General Appeals Account. Frankston RSL act as an Agent of the RSL Victoria State Branch General Appeals Account. Appeals monies are primarily raised through the annual ANZAC and Poppy Appeals each year. During 2021, \$44,729.00 was spent supporting veterans and their families. The 2021 closing balance on the Appeals was \$53,556.00, which was primarily raised through the 2021 Poppy Appeal. These funds will be carried forward in to 2022 to continue supporting the veteran community.

Despite the issues over the past two years, the Frankston RSL was in a very strong financial position at the end of 2021, which places us in a good position going forward for 2022.

I would like to acknowledge and thank the Management and Staff of the Sub-Branch, in particular the Finance Manager Lynda and her assistant Marion, for their on-going support in the management of our accounts throughout 2021.

#### **Review of Operations and Operating Results**

The surplus for the year amounted to \$186,889 (2020: deficit \$846,158).


